Objection to Claims; and due and proper notice of the 179th Omnibus Objection to Claims having been provided, and it appearing that no other or further notice need be provided; and the Court having found and determined that the relief sought in the 179th Omnibus Objection to Claims is in the best interests of the Debtors, their estates, creditors, and all parties in interest and that the legal and factual bases set forth in the 179th Omnibus Objection to Claims establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor, it is

ORDERED that the relief requested in the 179th Omnibus Objection to Claims is granted to the extent provided herein; and it is further

ORDERED that, pursuant to section 502(b) of the Bankruptcy Code, the claims listed on **Exhibit "A"** (the "**Order Exhibit**") annexed hereto under the heading "Claims to be Disallowed and Expunged" are disallowed and expunged; and it is further

ORDERED that this Order has no res judicata, estoppel, or other effect on the validity, allowance, or disallowance of, and all rights to object on any basis are expressly reserved with respect to any claim listed on Exhibit "A" annexed to the 179th Omnibus Objection to claims under the heading "Claims to be Disallowed and Expunged" that is not listed on the Order Exhibit; and it is further

ORDERED that the time for a claimant to seek an appeal from the entry of

this Order shall begin to run from the date this Order is entered as opposed to the date of

the Hearing;

ORDERED that this Court shall retain jurisdiction to hear and determine

all matters arising from or related to this Order.
