We write in connection with the *Motion of General Motors LLC Pursuant To 11 U.S.C. §§ 105 And 363 To Enforce This Court's July 5, 2009 Sale Order And Injunction (Monetary Relief Actions, Other Than Ignition Switch Actions) (with schedules and exhibits)* (the "Motion"), and the Scheduling Order entered by the Court in connection therewith on September 15, 2014 ("Scheduling Order").
