Relief Sought

No response is required to the Trust's prayer for relief. To the extent a response is required, PFRS denies all claims for relief and denies the allegations set forth in the prayer for relief

AFFIRMATIVE DEFENSES

In asserting the following defenses to the Trust's claims, PFRS does not concede that the assertion of such defenses imposes any burden of proof or persuasion on it with respect thereto, nor does PFRS assume the burden of proof or persuasion for any of the defenses set forth herein or any matter as to which the Trust as Plaintiff has the burden. Further, PFRS reserves the right to supplement, amend, or delete any or all of the following affirmative defenses prior to any trial of this action to the extent that its ongoing investigation and/or discovery so warrant. Presently, PFRS asserts that the claims alleged in the Complaint are barred, wholly or partially, because:

FIRST DEFENSE

The Complaint fails to state a claim against PFRS upon which relief may be granted.

SECOND DEFENSE

The service of process on PFRS was insufficient, and the Trust's claims should therefore be dismiss for failure to serve PFRS properly.

THIRD DEFENSE

The claims asserted in the Complaint against PFRS are barred by the doctrines of laches and equitable estoppel.

FOURTH DEFENSE

The claims asserted in the Complaint against PFRS are barred by applicable statutes of limitations.

FIFTH DEFENSE

Any Termination Statement is void and ineffective because JPMorgan Chase Bank, N.A. ("JPMorgan"), in its capacity as Administrative Agent for the Synthetic Lease, was

not the secured party of record under the Term Loan UCC Financing Statements and therefore had no power or authority to authorize the Debtors to file the Termination Statement.

SIXTH DEFENSE

Any Termination Statement is void and ineffective because JPMorgan never obtained the consent of PFRS to permit the Debtors to file the Termination Statement as required under the Term Loan Agreement.

SEVENTH DEFENSE

Any Termination Statement is void and ineffective because JPMorgan, both in its capacity as Administrative Agent for the Synthetic Lease and in its capacity as Administrative Agent for the Term Loan, exceeded the extent of its authority as an agent of its principals, including PFRS, when it permitted the Debtors to file the Termination Statement.

EIGHTH DEFENSE

Any Termination Statement is void and ineffective because JPMorgan did not authorize its filing.

NINTH DEFENSE

The unauthorized and ineffective filing of the Termination Statement did not waive or terminate the security interests that PFRS had in certain assets of the Debtors pursuant to the Term Loan Agreement and the Term Loan UCC Financing Statements.

TENTH DEFENSE

PFRS was a secured party and had perfected security interests on the Petition Date in certain assets of the Debtors pursuant to the Term Loan Agreement as set forth in multiple UCC-1 financing statements filed throughout the United States, including, but not limited to the UCC-1 financing statement numbered 6416822 3 and filed on November 30, 2006 with the Secretary of State of Delaware listing Saturn Corporation as the "debtor."

ELEVENTH DEFENSE

The claims asserted in the Complaint against PFRS are barred by the doctrines of *in pari delicto*, unclean hands, and/or the *Wagoner* Rule.

TWELFTH DEFENSE

The claims asserted in the Complaint against PFRS are barred by the doctrine of mistake, restitution, and unjust enrichment, which requires reinstatement of any erroneously discharged security interest.

THIRTEENTH DEFENSE

The Bankruptcy Court should find that the Debtors held the collateral under the Term Loan Agreement pursuant to a constructive trust for the benefit of PFRS and the other Term Lenders, and that therefore such collateral is excluded from the bankruptcy estate.

FOURTEENTH DEFENSE

The claims asserted in the Complaint against PFRS are barred by the doctrine of earmarking.

FIFTEENTH DEFENSE

The claims asserted in the Complaint are barred by the single satisfaction rule set forth under section 550(d) of the Bankruptcy Code.

SIXTEENTH DEFENSE

The claims asserted in the Complaint are barred to the extent that PFRS is not a transferee from which the Trust may recover the value of an avoided transfer under section 550(b) of the Bankruptcy Code.

SEVENTEENTH DEFENSE

The Trust lacks standing and authority to bring the claims alleged, and the claims did not survive the confirmation of the Debtors' chapter 11 plan.

EIGHTEENTH DEFENSE

At the time any of the purported transfers referenced in the Complaint were allegedly made by the Debtors, PFRS was a perfected secured creditor thereby excepting all of the alleged transfers from avoidance as preferential transfers pursuant to section 547(b)(5) of the Bankruptcy Code.

NINETEENTH DEFENSE

Pursuant to section 547(c)(2) of the Bankruptcy Code, the purported transfers sought from PFRS were (i) in payment of a debt incurred by the Debtors in the ordinary course of business or financial affairs of the Debtors and PFRS, (ii) made in the ordinary course of business or financial affairs of the Debtors and PFRS, and (iii) made according to ordinary business terms.

TWENTIETH DEFENSE

The claims asserted in the Complaint against PFRS to avoid transfers under section 549 of the Bankruptcy Code are barred to the extent that such transfers were not property of the estate.

TWENTY-FIRST DEFENSE

The claims asserted in the Complaint are barred to the extent that PFRS did not receive a transfer made under the Term Loan Agreement on May 27, 2009.

TWENTY-SECOND DEFENSE

The claims asserted in the Complaint are barred to the extent that any of PFRS did not receive a transfer made under the Term Loan Agreement on June 30, 2009.

TWENTY-THIRD DEFENSE

The claims asserted in the Amended Complaint against PFRS are barred by the doctrines of recoupment and/or setoff.

TWENTY-FOURTH DEFENSE

Any injury or damages to the Trust should be reduced to the extent that the culpable conduct of others caused or contributed to any injury or damages that the Trust may have sustained.

TWENTY-FIFTH DEFENSE

Pursuant to the Term Loan Agreement, the Debtors agreed to hold harmless and indemnify each Term Lender to the full extent of any losses, expenses, claims, or proceedings related to or arising out of the Term Loan Agreement. PFRS hereby invokes all of its contractual and common law indemnity rights, and hereby provides notice to the Trust and the Debtors thereof.

DEMAND FOR JURY TRIAL

PFRS hereby demands, pursuant to Rule 38 of the Federal Rules of Civil Procedure and Rule 9015 of the Federal Rules of Bankruptcy Procedure, a trial by jury of all issues raised in this adversary proceeding.

WHEREFORE, PFRS respectfully requests that judgment be entered in its favor as follows:

- A. Dismissing with prejudice the Trust's Complaint in its entirety and on the merits;
- B. Awarding PFRS its costs of defending this action, including reasonable attorneys' fees, costs, and disbursements; and

C. Awarding PFRS such other and further relief as this Court may deem just and proper.
