## ORDER GRANTING DEBTORS' ELEVENTH OMNIBUS OBJECTION TO CLAIMS (Duplicate Claims)

ORDERED that, pursuant to section 502(b) of the Bankruptcy Code, the claims listed on **Exhibit "A"** annexed hereto under the heading "Claims to be Disallowed and Expunged" (collectively, the "**Duplicate Claims**") are disallowed and expunged; and it is further ORDERED that the claims listed on Exhibit A annexed hereto under the heading "Surviving Claims" (collectively, the "Surviving Claims") will remain on the claims register, and such claims are neither allowed nor disallowed at this time; and is further

ORDERED that the disallowance and expungement of the Duplicate Claims does not constitute any admission or finding with respect to any of the Surviving Claims; and it is further

ORDERED that this Order has no res judicata, estoppel, or other effect on the validity, allowance, or disallowance of, and all rights to object on any basis are expressly reserved with respect to, (i) any claim listed on Exhibit A annexed to the Eleventh Omnibus Objection to claims under the heading "Claims to be Disallowed and Expunged" that is not listed on Exhibit A annexed hereto and (ii) any Surviving Claim; and it is further
