# ORDER GRANTING DEBTORS' 187th OMNIBUS OBJECTION TO CLAIMS (Qualified Defined Benefits Pension Benefits Claims of Former Salaried and Hourly Employees)

Omnibus Objection to Claims; and due and proper notice of the 187th Omnibus Objection to Claims having been provided, and it appearing that no other or further notice need be provided; and the Court having found and determined that the relief sought in the 187th Omnibus Objection to Claims is in the best interests of the Debtors, their estates, creditors, and all parties in interest and that the legal and factual bases set forth in the 187th Omnibus Objection to Claims establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor, it is hereby

ORDERED that the relief requested in the 187th Omnibus Objection to Claims is granted to the extent provided herein; and it is further
